AB 10-70 Public Hearing – Setting 2011 Property Tax Rates

David Glasson, Finance Director, presented the agenda bill. He explained that Resolution 2010-8 is for a 1% increase in property taxes, plus any new construction. The amount of the increase for 2011 is \$5,413 over the collections for 2010. Mayor Andrew opened the public hearing at and asked for comments and being none closed the public hearing. **C. Moore made the motion to approve the agenda bill with C. Linhart seconding. 5 Ayes 0 Nays, motion passed.**

AB 10-71 Adopting the Pacific County All Hazard Mitigation Plan  
Resolution 2010-7

David Glasson, Finance Director, presented the agenda bill. The cities of Raymond, South Bend, Long Beach and Pacific County worked through PCEMA to create the Pacific County Hazard Mitigation Plan. Once the plan is adopted, the city of Long Beach will be eligible for mitigation money after a presidentially declared disaster. **C. Phillips**

**made the motion to approve Resolution 2010-7 with C. Zuern seconding the motion. 5 Ayes 0 Nays, motion passed.**
