AB 11-19 Public Hearing on Amendments to City Code

David Glasson, Long Beach Volunteer Fire Chief, presented the agenda bill explaining an automatic response will increase available personnel on incidents scenes in a timelier

manner. C. Phillips made the motion to approve the agenda bill with C. Maxson seconding the motion. 5 Ayes 0 Nays, motion passed.

AB 11-22 Reschedule hearing for Annexation of Anderson Property

Gayle Borchard, Community Development Director, is requesting the public hearing be rescheduled to April 4, 2011. C. Linhart made the motion to approve the agenda bill with C. Maxson seconding the motion. 5 Ayes 0 Nays, motion passed.

WS 11-08 Discussion of the Selection of New Playground Equipment
