AB 11-36 Beach Gap Road Maintenance with State Parks

David Glasson, Finance Director, presented the agenda bill explaining Washington State Parks pays for the maintenance of the gap roads in the City \$5000 per gap road, per fiscal year for each gap road open for public vehicle access. AB 11-37 Request for Exceptions to Design Standards

Gayle Borchard, Community Development Director, presented the agenda bill. She explained the exceptions are to install gravel rather than a paved roadway and to use a

grinder pump and a 2" line instead of full-on sewer. The basis for the exceptions is the relatively high cost of the standard improvements compared to the market value of the parcel served. C.
