2014 REQUIREMENTS FOR LOW INCOME SENIOR CITIZEN DISCOUNT RATE

The following will be low income senior citizen discount rate guidelines:

- 1. The low income senior citizen discount will apply only to the base rate for the billing.
- Current full-time residential customers of the City of Long Beach, Washington Utility System may apply for a discount under the Utility Discount Program by filing an application attesting and affirming to the following:
 - a. Utility service is under the occupant's (applicant's) name.
 - b. The applicant has been a full-time resident in the Long Beach Utility Service area using utilities for not less than one (1) year.
 - c. Senior Citizen is Age 65 or older as of January 1, 2014.
 - d. Rates for applicants approved for the Senior Citizen Low Income Utility Discount Program shall receive the following credit against the applicant's utility bill for each calendar year.

- e. Eligible residential customers are required to reapply for this program on an annual basis.
- 3. The total income from all sources of <u>everyone living in the home</u> shall be reported. If this is a new application, please provide a <u>copy of your</u> <u>2013 IRS Tax Return with schedules</u>, along with supporting documentation. (the City will not keep these documents, but you must present them when you apply in person to the City for the discount.)


